SUBJECT: *Report of the President* PRESENTED BY: Dr. Tilly, President – Fleming College

Achieving Excellence in Student Learning

The Event Management students of Fleming College have been involved with organizations that raised greater than \$200,000 for the community. Some of the organizations that had applied projects with or the students volunteered with to gain experience were: Fleming Advancement and Alumni Relations; the Greater Peterborough Innovation Cluster; Jamaica Self-Help; Peterborough United Way; Greater Peterborough Health Services Foundation; A Place Called Home; Bridgenorth Ennismore Lakefield Rotary; Canadian Cancer Society; and Habitat for Humanity.

On April 24, 2012, *seven Fleming College students* from the Tourism and Travel, General Business and Office Administration programs travelled to Montego Bay, Jamaica for one week. Throughout the semester, the students raised more than \$1,000 and purchased school supplies, blood pressure monitors, diapers, hygiene and toiletry supplies to take with them to Jamaica. As part of the Peterborough County Recognition Awards, Fleming College student *Spencer Haslehurst* will receive an Act of Heroism Award, presented to individuals who have displayed bravery in the face of personal risk, injury or death, at an incident that took place either in the County of Peterborough or was to the benefit of a County of Peterborough resident. Spencer, along with other 2012 recipients, will receive his award at an event on May 25, 2012. From the media release: *On the morning of January 24/12, Spencer was driving on Mount Pleasant Road on his way to school. The roads were icy and he saw a vehicle in front of him slide off the road and roll over into a swamp. He immediately pulled over, called for help and assisted the driver and her four children from the sinking vehicle to safety. No one suffered injury. "I think they would have gotten out on their own but I helped get them out faster and out of that cold water. I don't think of myself as a hero because I did what anyone else would have done. I'm just a regular guy. I didn't think about it, I just did it."*

Providing Superior Services and Facilities

An overview of *Key Performance Indicator* results will be provided as a separate agenda item. One noteworthy result is that our Athletics and Recreation facilities received the highest student satisfaction rating in the province. Congratulations go to Geoff Mathews and staff!

Each summer, staff undertake a number of *projects* to improve facilities and services. This process is now well underway and many faculty and staff are now located in temporary space. Many projects are slated to be completed in the summer; the board will receive more specific updates in the fall.

ELT has approved *two "lean" projects* designed to streamline processes for students. The "Add/Drop/Swap" project involves course selection; the "Education Plans" project addresses reduction of duplication and waste for plans developed for students with disabilities. The scope of these projects will be determined during the summer using the lean methodology.

Leading in Sustainability

The Canada Foundation for Innovation has announced that the College will receive approximately \$800,000 in funding from the College-Industry Innovation Fund. The Centre for Alternative Wastewater Treatment (CAWT) will use the funding to upgrade equipment used for their research of water and wastewater treatment technologies. In Ontario, for example, it is estimated that 4,000 abandoned mine sites could be hazardous to public health and safety, and to the environment. It is difficult to remove or immobilize highly soluble contaminants, but bacteriological treatment systems offer the promise of a relatively low cost approach for removing trace elements from wastewaters. This new equipment will benefit companies by enabling continued collaborative research projects on removing toxic trace elements in water.

Growing with Positive Results

Growth is a challenge for Fleming and other colleges, particularly given demographics. The primary growth for the College in 2012-2013 will be in international student enrolments. Further information will be provided in the fall.

Building Community Success

The 38th annual Canadian Association for Conservation of Cultural Property Conference is under way in Peterborough. The conference theme, the "Power of Preservation," looks at preservation aspects that highlight the significance, value, advocacy, and interpret the tangible and intangible aspects of what preservation specialists do in a wide scope of materials and disciplines. Fleming professors Gayle McIntyre and Cindy Colford are co-chairs of this five day event.

Developing the Fleming Working Environment

This summer Fleming College anticipates hiring 17 full-time faculty, strengthening our faculty complement and expertise.

Other

Warren Craft is on track to reach \$100,000 in pledges for the annual bike-a-thon for Camp Kawartha. Of the 7,700 individual donations over twenty years, Warren estimates over 5,000 are attributed to his Fleming family of supporters. The Green-in-Motion ride is this Sunday morning, May 27, 2012.

MaryLynn West-Moynes has been appointed as President and CEO of Georgian College, effective August 7, 2012. Ms. West-Moynes is currently Vice President of External Relations at the University of Ontario Institute of Technology. Previously, she served as President of Mohawk College and in numerous leadership roles at both UOIT and Durham College.

The College shall be carried on without purpose of gain for its members, and any profits or other gains to the College shall be used in promoting its purpose.

8.3 Governor Nesbitt, Chair of the Finance and Property Committee, presented the <u>2012-2013</u> <u>Financial Plan</u>. It is a balanced budget, with projected revenues and expenditures of \$93-million, which is a slight increase from the previous year's budget.

The Chair noted that this was the 28th and final College budget for Ms. Blacker-Thomson who will retire later this year, and extended the Board's thanks to her and the staff of the Finance department for their assistance over the years. Thanks were also extended to Ms. Cameron, retiring later this year as well after 21 years at Fleming.

Dr. Tilly confirmed a media release would be issued following the meeting and expressed his appreciation to staff in bringing the plan forward at the start of the fiscal year.

8.4 Presented by Governor Maki, the Academic and Student Affairs Committee reviewed a proposal to offer a <u>new program, Wireless Information Networking</u>. This is the third in a series of graduate certificates targeted primarily at the international audience; as such, the Committee requested a report back on the overall package of programs developed for the international market within the next year.

THAT the Board of Governors of Sir Sandford Fleming College approve the *Ontario College Graduate Certificate in Wireless Information Networking* program effective September 2012, for forwarding to the Ministry of Training, Colleges and Universities for funding approval.

There was agreement that providing the Executive Summary and program costing information with the motion sheet was very helpful. Responding to a series of question with respect to how this program integrates within the current IT infrastructure, the Committee Chair reiterated that one of the outcomes of the process for new program development and approval sees proposals coming forward without all the details worked out.

8.5 The outcome of the <u>internal election process</u> was announced. *Sue Kloosterman*, Manager of Records, was elected by acclamation as the Administrative Staff representative on the Board, for a three-year term commencing September 1, 2012. *Heather Kerrigan*, Marketing Consultant, will serve as the Support Staff representative, also for a three-year term. The student representative, for a one-year term, will be *Ed Sexton*, a mature student in the Environmental Technology program at the Frost Campus. One internal position – the student observer – remains unfilled at this time; there has been limited interest in the role.

- 8.6 <u>Fundraising Outcomes for 2011-2012</u>: Governor Hayes, Chair of the Advancement Committee, announced the Advancement and Alumni Relations Office had surpassed the fundraising goal by securing \$1,609,290 to support student financial assistance and college capital projects. The Report was received, for information.
- 8.7 Governor Maki, Chair of the Academic and Student Affairs Committee, presented a <u>revised</u> <u>College Policy on Ethical Conduct for Research Involving Humans</u>. The Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans (TCPS) is the official human research ethics policy of Canada's three research agencies; this document has been updated and replaced by TCPS 2 which in turn necessitates revisions to Fleming's Policy.

It was questioned whether the policy made reference to Aboriginal-based research and whether the definition of research has been broadened to capture undertakings that may not necessarily be a formally-based research project. The move to graduate certificate level programs with applied project activities could conceivably fall into this broader definition of research.

2.	An update on field placement outlined the various hospitals, clinics and private agencies that were able to provide shadowing experiences and placements for our students.	
3.	Self assessment is now being introduced in the second semester Field Experience Preparation course. This includes placement expectations, communication, confidentiality, introduction to portfolio development, developing professional competencies and setting professional goals. These changes were well received by the students and placement agencies.	
4.	Input from industry included a discussion on student placement evaluation and the agency's internal processes that need to take place before a student can start their placement.	
5.	The Dean's report which was pre-circulated highlighted enrolment, the "Lean Project" and the new Kawartha Trades and Technology Centre scheduled to open in the fall of 2014.

Therapeutic Recreational professionals assist individuals in a variety of clinical settings, assisting in reducing or eliminating the effects of their illness or disability.

The graduate certificate program has been developed in response to the tremendous growth that has been experienced in both scope of practice as well as the employment opportunities available for graduates of the program. Aligned with the needs of the community service sector, courses have been designed to reflect both theory and practice and will be offered through blended learning and online formats. The first and second semester consist of seven courses per semester incorporating many of the required subject areas required for entry into the credentialing body of Therapeutic Recreation Ontario. A placement in the final semester will also provide students with the applied learning experience.

Executive Summary Proposal to Offer an Ontario College Graduate Certificate in Therapeutic Recreation

Therapeutic recreation is a process that utilizes functional intervention, education and recreation participation to enable persons with physical, cognitive, emotional and/or social limitations to acquire and/or maintain the skills, knowledge and behaviours that will allow them to enjoy their leisure optimally, function independently with the least amount of assistance and participate as fully as possible in society. Therapeutic recreation intervention is provided by trained professionals in clinical, residential and/or community settings. (TRO, 2011)

Therapeutic Recreation (TR) professionals also referred to as Recreational Therapists, Activities or Activation Staff, Therapeutic Recreation Programmers and Planners or Life Enrichment Workers; provide recreational treatment services and activities for individuals with disabilities or illnesses. Using a variety of techniques, including arts and crafts, animals, sports, games, dance and movement, drama, music, and community engagements, Therapeutic Recreation professionals provide personalized services to maximize independent leisure functioning and enhance the well-being of their clients. Specifically, Therapeutic Recreation professionals help individuals reduce depression, delirium, stress, and anxiety; recover basic motor functioning and reasoning abilities; build confidence; and socialize effectively so that they can enjoy greater independence and reduce or eliminate the effects of their illness or disability. In addition, Therapeutic Recreation professionals help people with disabilities integrate into the community by teaching them how to use community resources and recreational activities. Therapeutic Recreation professionals are different from Recreation & Leisure Workers, who organize recreational activities primarily for enjoyment.

The field of Therapeutic Recreation has grown tremendously in relation to scope of practice as well as in the employment opportunities available. Career opportunities in TR can be found in long-term care facilities, hospitals, outdoor recreation/education centers, not for profits organization including social service agencies, organizations that support children, youth or people with developmental disabilities, addictions and other types of rehabilitative centers, educational and correctional institutions. With the increased momentum for this field to professionalize, there is a growing trend for TR professional's to become self-employed. The development of this program is opportune with excellent employment prospects for TR graduates; the alignment with future program accreditation initiatives and regulatory industry standards that are currently being created in order to respond to the shortage of skilled employees for this field. Employment opportunities are good locally, provincially and nationally.

The program is aligned with needs in the community service sector and compliant with MTCU program standards for courses and placements. Courses have been designed to reflect both theory and practice required for the CAAT Graduate Certificate level. Many of the courses will be offered in the classroom through blended learning as well as through online formats which reflects what local employers have indicated through Fleming Data Research's Employer Survey of the DSW Sector. A placement in the final semester has been designed to give students the applied learning experience required to successfully gain employment in the field as a TR professional.

The program fits well with the other community service related programs at Fleming including Recreation and Leisure Services, Social Service Worker, Child and Youth Worker, Developmental Service Worker, Community Justice Services, Drug and Alcohol Counsellor, and Practical Nursing. Strong support and direction for the program has been provided by the Program Advisory Committee. This community believes that the Therapeutic Recreation program is essential and is delighted to be partnering with Fleming students for placements and Fleming graduates as employees.

Executive Summary Proposal to Offer an Online Fleming College Certificate in Children's Mental Health

The School of Education, Health and Wellness is proposing to launch a part-time Fleming College Certificate in Children's Mental Health online through Ontario Learn commencing in September, 2012.

This certificate complements the current offerings in the school because it broadens the health and education program selection for students. This program will help to meet the healthcare industry challenge of recruiting and retaining qualified employees to work with infant, child and adolescent populations. These populations are presenting in greater numbers with complex and complicated mental health diagnoses.

In the past, mental health issues were rarely associated with the pediatric population and generally thought of as a disease attributed to adults. This assumption has been challenged in recent years according to current research and to our community partners working with this population. Depressive and anxiety disorders are among the 10 leading causes of disabilities that can be detected in early childhood. A recent study found that difficult infant temperament at 5 months of age and lifetime maternal depression are the two most important risk factors for atypically high levels of depressive and anxiety symptoms. It also showed that depression and anxiety tend to increase in intensity over the preschool years (*Krakow 4*).

This certificate would appeal to a broad base of interdisciplinary (health) care providers who are responsible for front-line clinical and consultation services in children's mental health environments. The intention of this certificate will be to enrich current practice, and to develop the skills to work effectively within the practitioners disciplines. It would also be open to parents with a vested interest in the mental health of their family. The curriculum would be focused on infant, child and adolescent populations.

Currently, no other Children's Mental Health Certificate is offered at the college level through Ontario Learn.

Graduates will be prepared with skills and expertise to accurately assess a project's feasibility from a variety of perspectives and, using industry tools and standards, prepare, design, layout and install both free-standing and roof mount solar photovoltaic systems. Graduates will also be able to troubleshoot and assess existing solar project performance.

Fleming's program is the first developed with both the theory and applied project experience.

The number of new solar projects being proposed (both provincially and nationally) has created a demand for skills labour in designing, planning, installing and maintaining solar projects. There are currently very few comprehensive training programs specific to planning and installation skills in the solar sector for roof mounted and free standing panels.

Fleming College has access to appropriate facilities and equipment as well as trained staff to offer the program.

THAT the Board of Governors of Sir Sandford Fleming College approve the *Fleming College Certificate in Solar Photovoltaic System Planning and Installation,* effective June 2012.

Executive Summary Proposal to Offer a Fleming College Certificate in Solar Photovoltaic System Planning and Installation

This proposal recommends the launching of a comprehensive Solar Photovoltaic (PV) System Planning and Installation program. The program will offer a Fleming College Certificate of Completion. This certificate program will offer a full curriculum of solar photovoltaic (PV) system theory, PV system planning, design and installation best practices, system assessment and system maintenance following the standards of training required for certification as a Photovoltaic Installer by the North American Board of Certified Energy Practitioners (NABCEP) and the standards of the Canadian Solar Industry Association (CanSIA). The curriculum also reflects the Association of Canadian Community Colleges (ACCC) incorporating Modules A-G of Installer Level I.

The training offered in this program will prepare graduates with the industry skill set and expertise to accurately assess a site for a project's feasibility, determine a project's return on investment (ROI) using industry tools and standards, prepare a structural report for the structural engineer, design, layout and install a solar PV system from engineering drawings, select system components based on electrical schematics, assess an existing solar project's performance and troubleshoot underperforming systems. Graduates will work with both engineers and electricians in their capacity as qualified installers.

In 2010, Ontario ranked second for solar PV installations amongst US states and Canadian provinces and territories. This activity is expected to continue and Ontario is projected to remain the second largest solar PV market in North America. Coupled with the installation activity, at the end of 2011 there were more than two dozen solar PV module and inverter manufacturers in the province. This number is likely to increase as the need for panels increases with accompanying needs for qualified and certified installers.

The number of new solar projects that are being proposed both provincially as well as nationally is expected to drive significant job creation. This has created a demand for skilled labour in designing, planning, installing and maintaining solar projects. A Solar Planning and Installation Certificate will meet the emerging demand for these skills and includes the sustainability and safety required in this emerging field.

Currently, there are very few comprehensive training programs specific to planning and installation skills in the solar sector for roof mounted and free standing panels. Individuals interested in undertaking this type of work had to be trained on the job by personnel that had been inadequately trained. It is essential that more people be trained for employment in this skilled profession by competently trained people using the correct tools in a properly outfitted facility. Fleming College has access to the required facilities, equipment, and trained staff to offer this program.
