## ARTICULATION AGREEMENT

Between *Sir Sandford Fleming College* (hereafter referred to as the College)  
and  
*Youth Leadership in Sustainability (YLS) Program*

Articulation involves recognition of learning achievement, facilitates student progress, minimizes curriculum duplication and eases the transition from one institution to the other.

This agreement confirms an understanding of the articulation activities endorsed and supported by the College and YLS.

This agreement consists of the following components:

- Overview of the articulation activities and responsibilities
- Review guidelines
- Details of the agreement

### Responsibilities

It is the responsibility of Fleming College and YLS to support articulation activities.

1. YLS will inform the students of the articulation agreement with Fleming College
2. Fleming College will inform the Registrar's department and faculty in the School of Environment and Natural Resource Sciences (SENRS) about the articulation agreement.
3. The student will initiate the College application process and ensure that the appropriate documentation for the completed secondary school courses is available to the Registrar.

### Review guidelines

1. This agreement shall be subject to a joint review and subsequent modification by YLS and Fleming College
2. When the curriculum in any articulated course is revised, it will be the responsibility of the program delivering the revised course to notify the other contracting program.
3. Each organisation is responsible for keeping their administrative and instructional staff informed of any changes in this agreement.
4. This agreement may be terminated by either party at any time on written notice of 60 days before the start of the YLS semester, or shall be terminated if required by any policy or regulation of the

Ministry of Education to ensure compliance with the Education Act and policy directives as set by the Ministry of Training, Colleges and Universities.

**Details of the articulation agreement:**

YLS students who achieve passing grades (50%) in the two YLS environmental sustainability-themed OSSD courses “World Issues” (CGW4U/C) and “Environment & Resource Management” (CGR4M) will be granted a course credit for Fleming SENRS course “Skills for Stewardship and Sustainability” (NATR8).


**Additional activities to support the agreement:**

Fleming’s SENRS will provide guest speakers to YLS at mutually agreed upon times and locations as negotiated by YLS staff and SENRS staff/faculty. Further, SENRS will make classes, lab facilities and other special events available to YLS classes as mutually arranged.


