Re: Transfer arrangements Dear Mr. Ellis:

The enclosed transfer arrangement grid is intended to convey how the Sir Sandford Fleming Drug and Alcohol Programme courses will transfer, individually, to the requirements of the University of Lethbridge B.H.Sc. (Addictions) program. It has been delayed because I wanted to clarify more of the pieces, but I can delay it no longer. Several Arts and Sciences evaluators, normally vcry prompt, are just too busy at this time to give the normal turn time on recommendations, so you will see a number of 'Under review' comments against potential transfer credit arrangements. I can only say at this time that I do expect some transfer credit for these, but the ones so flagged definitely are not guaranteed. This is, very definitely, a preliminary draft with respect to anything flagged as under review.

However, we did not want your students to wait any longer, and will proceed with all the transfer arrangements about which we are confident.

We now have offers in the mail to several of your students, and the enclosed has been our guide for their Transfer Credit Statements. They will not have been given transfer credit yet for the 'Under review' courses, but I wanted you to understand the potential for improvement, and that we are working on it. One such potential improvement involves your computing science course, which is being evaluated but does not yet appear on the transfer grid.

By exception, your course, 'Introduction to Helping Relationships' will transfer with virtual certainty as HLSC 2850 (Introduction to Helping Relationships). HLSC 2850 will be a new course for us; legislation has to be drafted and approved by the appropriate committees, but Dr. McGowan anticipates no difficulty in this process.

This should give you a fair idea of how the course by course transfer arrangements will work, until such time as a post-diploma program is implemented.
