In order to bring you up-to-date on the articulation activities that we were working on together in your role as Dean of Access, the following report is offered, which summarizes the status with area school boards for french immersion and portfolio development, as well as the GM/ Robert Isabelle PLA project:

1.a. As of January 1997, we have signed agreements in French Immersion with Peterborough, Victoria, and Northumberland-Clarington County Boards of Education and the Peterborough, Victoria, Northumberland & Clarington Roman Catholic Separate School Board.

1.b. The original copies are on file in the Registrar's Office.

1.c. As a result of questions put to the Vice President and me by the Separate Board at the time of signing, regarding how such agreements are made known to students, Terry agreed that I should explore that issue for these Immersion agreements.

1.d. As a result of discussions with Northumberland-Clarington Board's Superintendent of Program, Trudy Lum, regarding the Immersion Agreement, a desire has been expressed to explore other linkages. I have conveyed this to Brenda Liston-Hanley.

2. In conjunction with Centennial and Durham Colleges, we are now at the stage of informing GM workers as to what college credits they will be granted, as a result of the Corporate Assessment/PLA Project funded by HRDC, through Robert Isabelle Inc. in 1995. Those credit awards are also in the hands of the Registrar, so that local GM employees can use them
