Trent University's

Bachelor of Social Work (Honours)

This agreement establishes the principles, guidelines and procedures governing admission and assessment of selected qualified students to enter Trent University (Trent) on an advanced standing basis, subsequent to the successful completion of the Mental Health and Addiction Worker Diploma program at The Sir Sandford Fleming College of Applied Arts and Technology (Fleming College).

1. PURPOSE

- 1.1. The purpose of this agreement is to provide qualified graduates of Fleming College's Mental Health and Addiction Worker Diploma program with a seamless option for continuing their education in the Bachelor of Social Work (Honours) degree program at Trent University. It is important to note that entry into third year of the Bachelor of Social Work (Honours) program includes an additional application process. Admission into the Professional Years is very competitive. Students not accepted into the third year of the program will be required to choose another major to continue studies at Trent. Students are encouraged to meet with an academic advisor for degree planning assistance.

2. ROLES AND RESPONSIBILITIES

2.1. Student Supports

Trent's program faculty will support incoming students by providing them with relevant information related to their program.

2.2. Admissions

The Admissions Office at Trent University will be responsible for ensuring that eligible students will be awarded credit transfers as stated in said agreement.

2.3. Recruitment and Marketing

Recruitment and Marketing representatives at Trent University will be responsible for promoting the articulation pathway and recruiting students.

2.4. Students

Through communication with program faculty and orientation sessions, students will be advised to consult academic advisors to ensure they are successfully completing program requirements.

3. TERMS AND CONDITIONS OF THE AGREEMENT

- 3.1. Graduates of Fleming College's Mental Health and Addiction Worker Diploma program will be granted 5.0 credits towards a 20.0 credit Bachelor of Social Work (Honours) at Trent University.
- 3.2 This agreement accepts students into the second year of the Bachelor of Social Work (Honours) program. Students are required to apply for entry into the third year in order to continue with the Professional Years of the program. Students not accepted to the third year of the program will be

required to choose an alternate major to continue studies at Trent. The transfer credits awarded to a student through this agreement will remain with the student in their alternate program of study, though credits received may not fulfill major requirements. Students can complete either a general or honours degree at Trent University in their alternate program, subject to specific program regulations. Students are strongly encouraged to meet with an academic advisor to ensure they are registering for courses to fulfill the requirements of both the Professional Years application and the alternate major.

3.3 Students who have graduated from Fleming College’s Mental Health and Addiction Diploma program, who commenced studies since Fall 2017, will be awarded the full 5.0 transfer credits provided they meet admission requirements under Article 4 of this agreement.

4. ADMISSION REQUIREMENTS

4.1. To qualify for this agreement, students must have:

- successfully completed Fleming College’s Mental Health and Addiction Worker diploma program;
- a minimum overall average of 75%.

4.2. Students must meet all specific admission and enrollment standards, and requirements for the program and will be accepted subject to capacity if applicable.

5. TRANSFER OF CREDITS

5.1. Students who are eligible, graduating from Fleming College’s Mental Health and Addiction Worker Diploma program with a minimum average of 75%, will be granted 5.0 credits towards the successful completion of a 20.0 credit Bachelor of Social Work (Honours) degree at Trent University. Credits will be transferred as follows:

5.2. As these credits recognize areas covered in Fleming College’s Mental Health and Addiction Worker Diploma program rather than one-to-one course equivalents, numerical grades will not be recorded on the Trent transcript. Completion of these credits will be recognized with a pass grade.

6. PROGRAM AND GRADUATION REQUIREMENTS

6.1. Upon admission to the Bachelor of Social Work (Honours) degree program at Trent, students must satisfy all general education, graduation and major requirements as outlined in the University’s undergraduate calendar. If a student does not have the foundation or skills to enroll in an upper level course because of a lack of the appropriate introductory course(s), any necessary prerequisite course(s) will be required.

6.2. If a student transfers to a different degree program, all transfer credits outlined in this agreement may not apply to the new degree program. It is the student’s responsibility to consult an academic advisor, and to notify the Registrar’s Office of any program changes.

6.3. To satisfy the requirements to apply to the Professional Years of Trent’s Bachelor of Social Work (Honours) degree program, students will need to complete specific courses to meet program requirements in addition to the courses they have already been granted from Fleming College.

ADMISSION REQUIREMENTS FOR THIRD YEAR/ENTRY INTO THE PROFESSIONAL YEARS OF THE BSW PROGRAM		
Without exception, to be considered for admission into Year 3 (the Professional Years), students must have met the following requirements by May 15 of the application year: <ul style="list-style-type: none"> • Successful completion of SWRK 1000H, 1001H, 2001H and 2004H (or equivalent); • A minimum grade of 70% in each of the completed Social Work courses (1000H, 1001H, 2001H and 2004H); • A minimum of 10.0 credits with a minimum cumulative average of 70%. 		

6.4. Students from Fleming College’s Mental Health and Addiction Worker Diploma program will be _____ granted 5.0 transfer credits upon admission. Students are required to take an additional 5.0 credits _____

to meet specific program requirements in order to apply for the third year of the Bachelor of Social Work (Honours) degree program. Should students be accepted into the Professional Years of the program, they will need to complete an additional 10.0 credits to fulfill departmental degree requirements.

- 6.5. Students applying to the Professional Years of the Bachelor of Social Work (Honours) program will be evaluated on their Trent academic performance only, as all credits transferred are placed on the academic record as pass or fail. As a result, students are required to achieve a minimum 70% average in their courses at Trent in order to be considered for admission to the Professional Years of the program. Admission to the professional years of the program is competitive, and as a result, achieving the minimum required average does not guarantee admission.
- 6.6. Students who are not accepted into the Professional Years of the program will be required to select an alternate major to continue studies at Trent. Indigenous Studies, Psychology and Sociology are recommended as alternate major choices due to transfer credits received.
- 6.7. Students are strongly encouraged to consult with an academic advisor prior to beginning their studies. Degree planning may require completion of summer courses in order to ensure students do not have to extend their studies at Trent should they need to declare an alternate major.

7. IMPLEMENTATION AND REVIEW

This agreement is subject to review whenever either party makes curricular changes that impact the agreement. When a change occurs, the program departments will notify their respective articulation designates so that the agreement can be updated. Articulation designates at each institution will review the agreement annually to ensure it is current. This Agreement may be terminated by either party. In this case, notice of one year is required. In the event of termination of the Agreement, every effort will be made to ensure that students currently enrolled in the program will not be affected.

8. ACCEPTANCE OF AGREEMENT


