

**ARTICULATION AGREEMENT**

This articulation agreement is dated as of this 26th day of February 2013.

**BETWEEN:**

**THE UNIVERSITY OF ONTARIO INSTITUTE OF TECHNOLOGY ("UOIT")**

and

**SIR SANDFORD FLEMING COLLEGE OF APPLIED ARTS AND  
TECHNOLOGY ("Fleming")**

**Purpose**

- A. The Ontario Ministry of Training, Colleges and Universities and the Ontario Council on Articulation and Transfer (ONCAT) have articulated "the goal of improving overall access to post-secondary education through increasing the number, type and range of collaborative arrangements in Ontario, primarily in high affinity-high priority areas."
- B. It is the special mission of UOIT to provide career-oriented university programs and to design and offer programs with a view to creating opportunities for college graduates to obtain a university degree.
- C. The goal of this Agreement is the creation of consistent, flexible and seamless diploma/degree and degree/diploma bridging agreements for students enrolled in approved programs at UOIT and Fleming

**THE PARTIES COVENANT AND AGREE AS FOLLOWS:**

**ARTICLE 1  
INTERPRETATION**

**1.1 Definitions**

In this Agreement (including the recitals hereof), the following words and phrases have the meanings set forth below:

- (a) "Agreement" means this articulation agreement and any Schedules attached hereto, as the same may be amended, restated or modified from time to time;
- (b) "Program" means each of the academic programs offered by UOIT and Fleming identified in the Schedules;

- (c) "Program Requirements" means the requirements for admission into a Program as set forth in the Schedule applicable to such Program.

## **1.2 Construction.**

- (a) Any reference in this Agreement to "herein", "hereof", "hereto" or "hereunder" and similar expressions mean and refer to this Agreement and not to any particular Section or other subdivision;
- (b) "Section" or other subdivisions of this Agreement followed by a number means and refers to the specified Section or other subdivision of this Agreement;
- (c) the division of this Agreement into Sections and the insertion of headings are for convenience of reference only and shall not affect the construction or interpretation of this Agreement;
- (d) in this Agreement, unless the context otherwise requires, words importing the singular number shall include the plural and vice-versa;
- (e) whenever the words "include", "includes" or "including" are used in this Agreement, they shall be deemed to be followed by the words "without limitation"; and
- (f) this Agreement has been reviewed by counsel to both parties jointly by the parties and no rule that it be construed against the drafter shall have any application in its construction or interpretation.

## **ARTICLE 2 OBJECTIVES**

The parties agree that the objectives of this Agreement include:

- (a) delivering quality post-secondary programs and services in a manner and level of academic quality that is satisfactory to both UOIT and Fleming;
- (b) valuing the credential of the Fleming program and the UOIT program from which students have graduated;
- (c) improving accessibility to, retention in, and graduation from post-secondary programs from students at both UOIT and Fleming; and
- (d) developing further communication and relationships for the development and delivery of high affinity and innovative programs.

### **ARTICLE 3 ARTICULATION**

#### **3.1 Admission**

Each of the parties agrees to grant transfer of credits to graduates of the other party who are granted admission into such Programs and who meet the applicable Program Requirements; provided, however, that each of the parties hereby acknowledges and agrees that the satisfaction of Program Requirements by a student will not guarantee acceptance into a Program, and that each Program has limited enrollment and that preference will be given to applicants with the best qualifications.

#### **3.2 Application**

A student who wishes to apply for admission to a Program shall apply to UOIT or Fleming, as the case may be, in the manner prescribed by UOIT or Fleming, respectively, from time to time. Neither UOIT nor Fleming shall bear any responsibility for late, incomplete or deficient admission applications.

#### **3.3 Undertakings Regarding Academic Aspects of the Program**

Each of the parties hereto agrees:

- (a) to carry out their respective roles and responsibilities according to the process defined for each Program;
- (b) provided that the prior written consent of the applicable student is obtained, to share information regarding the academic status of students enrolled or applying for admission into a Program;
- (c) to evaluate Program curriculum on a regular basis, as required through the office of the Vice President Academic or an equivalent office. Such evaluation will consist of examination by the parties hereto of:
  - (i) the possible or anticipated changes to courses in a Program; and
  - (ii) Program admission procedures, time lines and special requirements; and
- (d) to, in a timely fashion, facilitate changes mutually agreed to by the parties, if any, to the Programs and Program admission procedures, time lines and special requirements, through their respective academic approval processes.

### **ARTICLE 4 PROMOTION**

- 4.1.1** Each of the parties agrees to promote the other party's Programs to prospective qualified students in such a manner as the parties shall agree upon from time to time. Each party will endeavor to link to each other's website and Program areas.

**4.1.2** During the term of this Agreement, each of the parties (for the purposes of this Section 4.1.2, a "Licensee") is granted a limited, non-transferable licence to display such trade-marks, trade names and logos (collectively the "Marks") of the other party (for the purposes of this Section 4.1.2, a "Licensor"), in accordance with the policies established by the Licensor from time to time. The Licensee acknowledges that the Licensor has exclusive rights to the Marks and that the use of the Marks shall be for the sole benefit of the Licensor. The Licensee acknowledges that its sole right with the respect to the Marks is to display the Marks in accordance with the Licensee's policies in connection with the promotion of the Licensee's Programs. The Licensor shall not use the Marks in any manner which the Licensor, in its sole discretion, considers misleading or objectionable. After the expiration or termination of this Agreement, the Licensee shall not use any of the Marks. The Licensee undertakes to inform the Licensor forthwith of any infringement of the Marks that comes to the Licensee's attention and to cooperate fully with the Licensor in any action the Licensor may take in respect of such infringement.

## **ARTICLE 5 CONFIDENTIAL INFORMATION**

Each party agrees to hold in strictest confidence, and not to disclose to any person or use in any way for that party's own or another's benefit, any information regarding the other party's students that maybe disclosed in connection herewith. Nothing in this provision will apply to any information which:

- (a) enters or has entered the public domain otherwise than by breach of this Agreement or of any other duty;
- (b) was publicly available at the time it was transmitted to the receiving party;
- (c) was properly provided to the receiving party by a third party without restriction; or
- (d) is required to be disclosed by law or by any governmental agency.

The parties agree that any violation of this confidentiality provision will result in irreparable injury to the other party and agree that each has the right to seek and obtain a restraining order, injunction, or any other remedies or in equity without proof of irreparable harm and without any requirement to post security.

## **ARTICLE 6**

The parties will work toward expanding the scope of this Agreement through the addition of schedules for agreed upon programs. Future schedules will not be part of the Agreement until the schedule has been reviewed by each institution.

## **ARTICLE 7 TERM**

### **7.1 Term**

This Agreement shall commence on April 1, 2013 and continue to and including October 31, 2017.

### **7.2 Termination**

The individual Schedules provided in this Agreement are in effect from date of signing for a period of five years with an opportunity for evaluation and review as required. The Schedules within this Agreement may be amended or renewed upon mutual agreement. Individual Schedules within this Agreement may be terminated by either party, upon notice to the other, one year in advance of the academic year in which the individual Schedule is to be terminated. The effective date of termination will be the beginning of the next semester following the expiry of the one year notice period. On the effective date of termination of an individual Schedule the party terminating the Schedule will no longer have any obligation to admit any graduate of the other party, conditional or otherwise, or to grant credits toward the respective program as required by the Schedule. The Agreement ceases to exist with the termination of all Schedules. Notwithstanding anything to the contrary in this Section 7.2, either party may terminate the Schedules and this Agreement forthwith without liability if the other party commences or acquiesces in proceedings for substantive relief in any bankruptcy, insolvency, dissolution, liquidation, winding up or other similar proceedings.

### **7.3 Effect of Termination**

Upon the expiration or termination of individual Schedules of the Agreement:

- (a) The parties shall forthwith at their own cost and expense, discontinue the display of the others' Marks; and
- (b) The parties shall promptly return to each other all documents and publications in their possession belonging to the other party.

### **7.4 Review/Change Mechanism**

It is recognized that modifications to existing degree programs range from changes to individual courses and curricular offerings, through minor adjustments to programs and regulations, to major program modifications such as the introduction of new specializations or altering learning outcomes.

Where it is necessary to review this Agreement due to major changes in the programs offered by either party, the party experiencing the program change will notify the other party forthwith and the parties shall enter into good faith discussions immediately to determine whether revisions to this Agreement are required.

**ARTICLE 8  
GENERAL**

**8.1 Relationship of Parties**

Nothing herein shall be construed so as to constitute the parties as a partner, joint venture, franchisee or franchisor, agent or representative of the other party for any purpose whatsoever. Neither party is authorized to enter into agreements for or on behalf of the other party or otherwise bind the other party.

**8.2 Notices**

Any notice between the parties hereunder shall be in writing and sent by delivery or telefacsimile to the address for each party as set forth below:

**8.3 Governing Law**

This Agreement shall be construed and enforced in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein. Any action or proceeding arising out of or relating to this Agreement must be brought in the courts of the Province of Ontario. Each of the parties hereby irrevocably attorns to the non-exclusive jurisdiction of the courts of the Province of Ontario with respect to any matter arising under or related to this Agreement and waives any objection it may now or hereafter have to venue or to convenience of forum.

**8.4 Entire Agreement**

This Agreement, including the Schedules hereto, and together with any other documents to be executed and delivered pursuant hereto, constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all other prior agreements, understandings, negotiations and discussions, whether oral or written, between any of the parties in that regard and there are no warranties, representations, covenants or other agreements between the parties, except as specifically set forth herein.

#### **8.5 Waiver, Modification - Requirement of Writing**

No waiver, modification or cancellation of any provision of this Agreement or of any breach of any provision of this Agreement, shall be effective unless executed in writing. No waiver shall excuse the performance of any act other than the act specifically referred to in such waiver. No assent to or waiver of any breach of any one or more of the covenants and agreements herein contained, whether such assent or waiver be expressed or implied, shall be deemed to be taken to be a waiver of any succeeding breach.

#### **8.6 Successors and Assigns**

This Agreement binds and benefits the parties and their respective heirs, executors, administrators, successors and assigns. Neither party may assign any rights under this Agreement without the prior written consent of the other party.

#### **8.7 Severability**

If any provision of this Agreement is held invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions of this Agreement are not affected or impaired in any way.

#### **8.8 Counterparts**

This Agreement may be executed simultaneously in counterparts, each of which shall be deemed an original, but which together shall constitute one and the same agreement.

#### **8.9 Language**

The parties have requested that this Agreement be drawn in the English language. Les parties ont demandé que cette entente soit rédigée en langue anglaise.
