



## **Articulation Agreement**

# College/University program (EAP)

This agreement becomes effective on **May 12, 2017** and replaces any previous agreement signed with Upper Madison College.

Between:

**Sir Sandford Fleming College** (hereinafter called "the College"); and **Upper Madison College** (hereinafter called "the Pathway Program Provider")

AND WHEREAS:

The College and the Pathway Program Provider agree to work together to facilitate the admission of qualified international students into post- secondary certificate, diploma, and post graduate programs. To that end, the following procedures will be implemented:

### 1. Admissions

- **1.1** The College will accept the successful completion of the EAP program (levels 10, 11, 12) of the Pathway Program Provider in ESL as demonstration of academic English language proficiency for admission to diploma or post-graduate programs with the exception of the Pharmacy Technician Program. As such, the graduate with the EAP certificate from Upper Madison College will not be required to produce an English language proficiency test score such as IETLS or TOEFL or any internal test.
- **1.2.** To be eligible to apply for the **College's** academic programs, students must meet all the entrance requirements for the specific program as outlined in the academic calendar/website and have a demonstrated proficiency in English at the agreed upon UMC passing grade level. Acceptance will be dependent upon the successful completion of the UMC EAP with the appropriate academic standing (average of 70% or more at the end of the final EAP semester, 70% or more at the final exam) to meet the entry requirements of the College's diploma and postgraduate programs.

#### 2. Promotion

- **2.1.** For purposes of promotion, the College will allow the Pathway Program Provider to use its corporate logo in order to promote this Articulation Agreement on the Provider's website, brochures or other marketing material. The Pathway Program Provider agrees to provide prompt response to the College's inquiries and will provide support to the College in promoting the agreement and ensure individual referrals to the International Office of the College for each student expressing interest.
- **2.2.** The College will provide the Pathway Program Provider core marketing materials such as brochures and viewbooks. The College agrees to visit the Pathway Program Provider to promote its progress as deemed convenient for the Provider. The College will inform the Pathway Program Provider of its ongoing information sessions on campus and seasonal Open Houses which prospective students are invited to attend. Each party is responsible for its own expenses.
- **2.3.** It is expected that UMC will provide the student with appropriate counseling regarding program choice and start date (as appropriate), prior to the submission of the student's application.

#### 3. Commission

**3.1.** For each student that enrolls at the college the commission payable will be according to the terms of the Recruiter Agreement under which the UMC advisor who assisted the student has in place with the College.

## 4. Terms of agreement

- **4.1.** The Pathway Program Provider will notify the Manager of Admissions, Student Recruitment and International Office at the College of any changes affecting the UMC curriculum and acknowledges that any changes may result in a change to the established Educational Pathway Agreement.
- **4.2.** This agreement can be canceled at any time by either party. Both parties must provide at least one month of written notice of agreement cancellation.
