Initially, 10 courses were proposed that required development. After review of the Fleming General Arts and Science – University Transfer program structure and discussions with the Academic faculty at Fleming and Trent, Fleming is concentrating on the Business, Math and Sciences streams, which will include an Indigenous course. It was determined that these eight courses will require the project course development resources.

There have been adjustments regarding course development as previously stated. The original budget noted \$35,000 for course development (10 courses @ \$3,500/course). However, the project team underestimated the expenditures involved with course development and as such will develop 6 courses @ \$5,000/course and re-develop 2 existing courses at \$2,500/course. This will meet the same contract values as originally proposed and ensure that the project team is on track with the project as outlined in the initial proposal.
