### POSITION SUMMARY

The Senior Development Officer is responsible for engaging with alumni and donors to inspire increased major gifts to Fleming College. Funding is to be secured through philanthropic and grant proposals made to private corporations, organizations, foundations, and individuals including alumni and community members.

The incumbent is responsible for the full scope of activities related to the identification, cultivation, solicitation, and recognition of a portfolio of major gift prospects and donors for a number of Schools at Fleming College. Fundraising projects include a variety of strategic College priorities, including student financial support, program and research support, gift in kind, and building campaigns.

The incumbent actively participates in department strategy development, alumni relations, and sound information management through Raisers Edge. They work closely with the Dean(s)/academic leader(s) and their office to enhance School engagement with alumni and donors.

Prospects managed by the incumbent will be rated at a major gift level from \$10,000+.</li><li>• Responsible for securing \$250,000 + in contributions annually through cash or gift in kind donations, grants, and sponsorships.</li><li>• Prepares a work plan with goals and objectives, as well as a timeline and strategies keeping a focus on advancing relationships with top prospects while continuing to integrate new prospects into the portfolio.</li><li>• Prepares, writes and submits customized applications and gift proposals. Negotiates and brings solicitations to closure, both independently and in conjunction with senior administrators. 3. Determines how best to advance major gift prospect relationships including which senior College officials and volunteers to involve and when to attempt to take the next step in a given relationship in an effort to secure the most impactful donation possible for the College and the donor. Poor decisions in managing relationships can result in reputational risk and failure of fundraising programs. Determines how to deal with complaints and how to resolve disputes and recognizes when a major issue should be brought to the attention of senior management.

- Capacity to exercise sound judgment and discretion and maintain confidentiality.
- Proven capacity to take initiative, be proactive, and meet deadlines.
- Excellent problem solving skills.

- 5 years of progressive experience in professional fundraising, with a focus on major gifts. University or College fundraising and major campaign experience an asset.

- Well-developed interpersonal and relationship building and management skills; ability to establish rapport with donors/donor prospects, staff and volunteers.
- Strong communication, research and analytical skills. Effective interpersonal skills, including the capacity to work effectively with faculty members and external stakeholders.
- Excellent written and oral communications skills; exact attention to detail for writing and understanding appropriate interpretation of grants.

- Strong and effective presentation skills.
- Strong problem-solving and analytical skills; proactive, creative, self-starter.
- Ability to handle a large volume of work under pressure and with deadlines.
- Experience working with Raiser's Edge database to develop reports to support donor cultivation, solicitation, stewardship and recognition efforts.
- Ability to work independently as well as in a team and manage time efficiently.
- A vehicle, or access to a vehicle, to meet with donors.
- Must possess a valid driver's license.

#### 4. INITIATIVE – INDEPENDENCE OF ACTION

Initiative – Independence of action refers to the **amount of responsibility** inherent in a position and the **degree of freedom** that an incumbent has to **initiate** or **take action** to complete the requirements of the position. An incumbent is required to foresee activities and decisions to be made, then take the appropriate action(s) to ensure successful outcomes. This factor recognizes the established levels of authority which may restrict the incumbent's ability to initiate or take action, e.g., obtaining direction or approval from a supervisor, reliance on established procedures/methods of operation or professional practices/standards, and/or built-in controls dictated by computer/management systems.

1. Conducts research to identify and qualify potential funding opportunities from private sources.
2. Cultivates prospective donors and moves them into the solicitation stage effectively in order to present and submit strategically appropriate funding requests. Requests are in the form of grants and gifts from private industry, foundations and individuals.
3. Stewards donors effectively and creatively to ensure a long-term positive relationship with the College. This takes many forms from timely gift receipting to donor recognition events.

### 5. POTENTIAL IMPACT OF DECISIONS

Potential Impact of Decisions recognizes the **potential consequences** that **errors in judgement** made by an incumbent, despite due care, could have on the College. Inappropriate or misinformed leadership of resource development strategies could result in loss of or diminished return of a major gift to the College; or, in effect, damage relationships with major College partners and subsequent deterioration of credibility and positive public relations, externally and internally. Such situations could seriously damage the financial viability of the Advancement & Alumni Relations Office and thereby place College projects, student enrolment and learning resources in jeopardy.
2. Engaging with an individual or organization that wishes to provide a gift for College initiatives - failing to ask probing questions that will ensure compliance with Canada Revenue Agency Charity Directorate Guidelines. For example, failing to inquire as to the nature of the relationship between an individual engaged in providing the gift, and the intended recipient could contravene 'arms-length' rule by CRA, potentially jeopardizing the College's charitable status.
3. Failure to follow appropriate Privacy regulations could cause legal action, financial loss to the College, and loss of reputation.

### 6. CONTACTS AND WORKING RELATIONSHIPS

Contacts and Working Relationships refers to the **types, importance** and **intended outcomes** of the contacts and working relationships required by an incumbent to perform the responsibilities of a position. It also measures the skill level required to be effective in dealing with contacts and being involved in working relationships. This factor does **not** focus on the level of the contact, but on the nature of the contact.
