## COACH CANADA Charter Services - Terms & Conditions of Contract

- 1. Rates are displayed in Canadian dollars.
- 2. Rates are subject to 13% Harmonized Sales Tax where applicable.
- 3. Rates do not include Tolls, and second driver costs. If other unforseen charges should occur such as admission charges, bridge crossing fees, Niagara Parks Fee or parking fees including hotel parking. Charges will be billed back.
- 4. Rates are based on the current cost of fuel and are subject to a possible fuel surcharge, should we experience a significant increase in the cost of fuel.
- Cancellations made within seven (7) days of service will be subject to review by management for cancellation charges up to a maximum of 100% of the charter cost. Cancellations made within thirty (30) days of service during the months of May/June/September/October will be subject to review by management for cancellation charges up to a maximum of 100% of the charter cost.
  Athletic Bookings Only:

Due to game schedules a charter may be cancelled within 2 days of service to avoid cancellation charges. Weather related cancellations made with 5 hours of deparute will not be subject to cancellation fees.

- 6. On multi-day trips, the customer is responsible to supply a suitable hotel/motel room for each driver. Each driver requires a separate, private, non-smoking room, with private washroom and a TV.
- 7. Rates are for one (1) driver unless otherwise specified. Please send in a final itinerary seven (7) days before each charter departure date for approval of "on-duty" and "off-duty" time. If, upon receipt of the itinerary, a secondary driver is required and additional charge will be applied.
- 8. Once the charter has departed, changes in the itinerary will be honoured, if possible, but only after the "Additional Work Request" section on the charter work order is completed. Additional time, distance, trips or stand-by will result in additional charges.
- 9. The customer is responsible for the cost to repair any damages to Coach Canada equipment that is a result of the customer's actions or for any excessive cleaning that is necessary. The customer is responsible, in this respect, for the actions of all passengers' actions.
- 10. Driver's Hours of Service: Coach Canada enforces more stringent Hours of Service rules in order to ensure a higher standard of safety. Days requiring longer than 9.15 hours of driving time will be subject to additional charges. 9.15 hours is inclusive of all 'behind-the-wheel" time driving. On trips longer than 1-day, please allow for a minimum of 9 hours off-duty time for the driver between each work period.
- 11. Any overnight drives will be surcharged for additional driver requirements.
