They are looking for new members. If interested, email pridealliance@flemingcollege.ca d) Miranda handed out postcards about a Fleming's Positive Space Campaign. e) Fleming has partnered with TransCare (a new clinic and education outlet). f) Space at Fleming is limited but will continue to advocate for dedicated safe space. g) A version of the Positive Space training will be offered during orientation. h) Pride Week at Fleming will run again next year in conjunction with Pride Alliance, SAC, TransCare, PARN, Trent, CMHA and Gender Journeys. i) Positive Space levels 1 & 2 will be offered to faculty/staff for HR credits. j) The sticker process for Positive Space training will be changing next year. k) Positive Space level 3 training has changed into an Ambassador Program for volunteers to lead level 1 workshops. Let Miranda know if you are interested in volunteering. l) A Student Rep Committee dedicated to positive space will start in September. m) Miranda is available to provide level 1 training in classrooms. Talk with your Program Coordinator about the possibility of inviting her. She would like co-presenters. n) Miranda will be meeting with the Registrar's office regarding the name change process. o) Carol will talk with program coordinators from both schools at the next Coordinator Meetings about integrating Positive Space into the curriculum.
