

COVID-19 COMMUNITY SAFETY STANDARDS

Fleming Commitment: Fleming Safe

Fleming College is committed to the health and safety of all Fleming College community members. The following standards have been implemented to reduce the spread of COVID-19. These measures are in place to ensure those on campus can participate in an environment that is safe and respectful to their wellness and the wellness of others. Students are expected to comply with the guidelines of the Public Health Agency of Canada (PHAC), the local Public Health Units, and policies of Fleming College.

Students Role in Maintaining a Safe Environment:

- Complete the COVID 19 Safety Training Prior to returning to campus
- Download the Fleming safe app
- Complete the COVID-19 Self Screening each day you are required to be on campus
- Bring a facial covering and/or non-medical mask and wear it while on campus. If you do not have one with you, we can provide you with one when you arrive.
- Limit movement to your designated area and only carry out approved tasks
- Physical Distancing – you are responsible for maintaining a distance of two (2) meters around their learning area and away from others at all times. If the learning activity requires less than 2 metres (6 feet) additional measures are required.
- Practice frequent hand washing especially after touching shared surfaces and prior to eating
- Avoid touching face
- Be aware of your surroundings – avoid entering others personal space
- Show care and kindness for others. Supportive language and gentle reminders are encouraged

Guidance if there is non-compliance with COVID standards in the classroom:

- Stop all activities in progress. If it is safe to do so, step away to re-establish safe distancing
- Faculty will notify the person not complying and offer an opportunity to correct their behaviour
- If there is refusal to comply, faculty or staff should contact campus security at x 8000 for assistance. The student can be asked to leave the area and the incident will be documented. This guideline can also apply to non-compliance in common areas outside of the classroom.
- Fleming College reserves the right to impose sanctions for any infraction or act of non-compliance with these standards in effect, following our Student Rights and Responsibilities policy and procedures: <https://department.flemingcollege.ca/srr/>
- Any sanction related to non-compliance in the classroom and potential implications to the students return to the classroom will be discussed with the Faculty, Chair, and/or Dean, and a copy of the sanction will be provided to the Chair or Dean.

Accommodations: Students who are unable to wear face coverings or other protective equipment and require accommodation must meet with an Accessibility Counselor to discuss and arrange accommodations prior to attending a class where this type of equipment is required.
